Introduction

We have examined whether the Board of Directors and the Managing Director of H & M Hennes & Mauritz AB (publ) have complied during the financial year 1 December 2009-30 November 2010 with the guidelines for remuneration to senior executives established at the Annual General Meeting of 4 May 2009 and the Annual General Meeting of 29 April 2010. The review encompassed the company's organisation and documentation of matters relating to the remuneration of senior executives, new decisions on remuneration that have been made and a sample of the payments that have been made to senior executives during the financial year. We believe that my/our review provides a reasonable basis for my/our opinion set out below.
